GENERAL INFORMATION: AlfaPower MP is formulated to be used on alfalfa, clover, grass hay, and pastures. It can also be used on most other crops. It contains various micronutrients. AlfaPower MP also consists of a dormant spore-based liquid that contains special secretions that are very beneficial to soil bacteria, both dormant and active. AlfaPower MP is designed to help increase the tonnage per acre and alfalfa quality.

MIXING INSTRUCTIONS: Put 1/3 to 2/3 of total water volume in tank. **1.** Add pesticide(s) if desired and agitate until thoroughly mixed. **2.** Add AlfaPower MP and agitate until thoroughly mixed. **3.** Add adjuvant(s) if desired and agitate until thoroughly mixed. Fill tank with remainder of desired water. A jar test is recommended for evaluating compatibility of AlfaPower MP with multiple product mixtures.

USE RATES (FOLIAR): **Alfalfa:** 2 qt/acre at green-up and within 1 week after each cutting. Add 1–2 pt/acre BorPower along with each application of AlfaPower MP. **Clover:** 2 qt/acre. Apply up to 4 applications per season. **Grass Hay and Pastures:** 2 qt/acre. Apply within 1 week after each cutting or as needed.

NOTICE: Some crops may be injured by the application of Boron, and excessive amounts may be toxic.
