**GENERAL INFORMATION:** BorPower is used on field crops, tree fruit, vegetables, and ornamentals for the prevention and correction of Boron deficiencies. BorPower is a combination of boric acid and organic acids. Use along with a regular fertilizer program for all crops requiring Boron. BorPower can be used with starter fertilizer if it's not placed in direct contact with the seed.

**MIXING INSTRUCTIONS:** Put 1/3 to 2/3 of total water volume in tank. **1.** Add pesticide(s) if desired and agitate until thoroughly mixed. **2.** Add BorPower and agitate until thoroughly mixed. **3.** Add adjuvant(s) if desired and agitate until thoroughly mixed. Fill tank with remainder of desired water. A jar test is recommended for evaluating compatibility of BorPower with multiple product mixtures.

**USE RATES:** **Corn:** 1 pt/acre at V6 to VT. **Soybeans:** 1–2 pt/acre at R1 to R3. **Cereal Grains:** 1 pt/acre at stage 4 to stage 8. **Forage Crops and Pastures:** 1–2 pt/acre at green-up and shortly after each cutting. Add 2 qt/acre of AlphaPower MP along with each application of BorPower. **Berries, Vegetables, and Tree Fruit:** 1–2 qt/acre per application throughout the growing season. At least two applications are recommended. More frequent applications at higher rates may be needed to correct any deficiencies. **Ornamentals:** 1–2 qt/100 gallons of water. Cover foliage thoroughly to the point of runoff. Repeat applications if necessary. **Broadcast:** 2–4 qt/acre. DO NOT place in direct contact with seed. **AERIAL:** 1 qt/acre with a minimum of 2 gallons of carrier per acre.

**NOTICE:** Some crops may be injured by the application of Boron, and excessive amounts may be toxic.

**KEEP OUT OF THE REACH OF CHILDREN:** Avoid contact with skin, eyes, and clothing. Avoid breathing spray mist. Wash hands thoroughly after use. **Personal Protective Equipment:** Wear long-sleeved shirt and long pants, socks, shoes, and gloves.

If the person is not breathing, call 911, then give artificial respiration, if possible.
