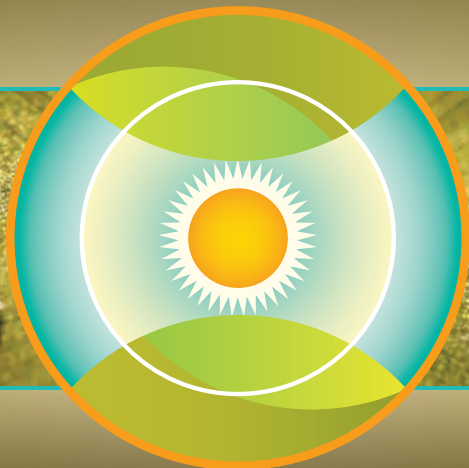

**GENERAL INFORMATION:** MagPower is a liquid micronutrient with Magnesium. MagPower is designed for use on all crops that require Magnesium.

**MIXING INSTRUCTIONS:** Put 1/3 to 2/3 of total water volume in the tank. **1.** Add pesticide(s) if desired and agitate until thoroughly mixed. **2.** Add MagPower and agitate until thoroughly mixed. **3.** Add adjuvant(s) if needed and agitate until thoroughly mixed. Fill tank with remainder of desired water. A jar test is recommended for evaluating the compatibility of MagPower with multiple product mixtures.

**NOTICE: Do not mix with fertilizers containing Phosphorus.** Check compatibility with chemical mixtures that include high phosphate and alkaline (high pH) solutions.

**USE RATES (SOIL/FOLIAR): SOIL:** 2–4 qt/acre via drip or sprinkler irrigation. **FOLIAR: General Use for all Field Crops, Berry Crops, and Vegetables:** 1–4 qt/acre per application. Begin first application at bloom. Make 3–6 applications through the season up to harvest or until the crop has sufficient levels of Magnesium. Dilute in an adequate amount of water for thorough coverage. **Tree Fruit:** 1–4 qt/acre per application. Begin first application at petal fall. Make 3–6 applications through the season up to harvest or until the crop has a sufficient level of Magnesium. Dilute in an adequate amount of water for thorough coverage. **Ornamentals:** 1–2 qt/100 gallons of water. Apply applications of MagPower until the crop has a sufficient level of Magnesium. Cover foliage thoroughly to the point of runoff.

**KEEP OUT OF THE REACH OF CHILDREN:** Avoid contact with skin, eyes, and clothing. Avoid breathing spray mist. Wash hands thoroughly after use. **Personal Protective Equipment:** Wear long-sleeved shirt and long pants, socks, shoes, and gloves.
