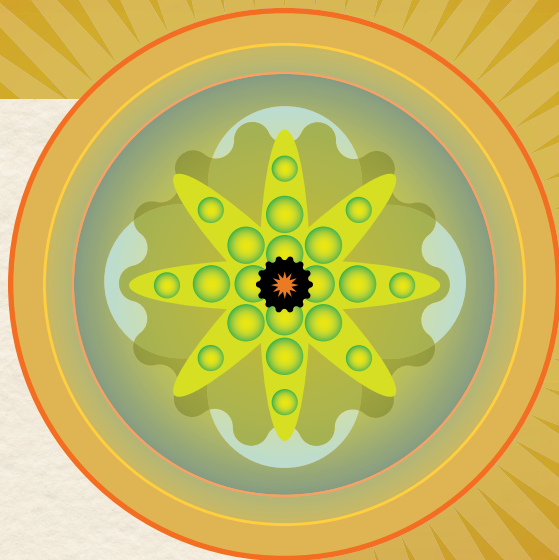

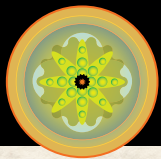

GENERAL INFORMATION: Manganese5% EDTA is a fully chelated solution designed to be used as a soil or foliar application for the prevention and correction of Manganese deficiencies in all crops. Use along with a regular fertilizer program for all crops requiring Manganese.

MIXING INSTRUCTIONS: Put 1/3 to 2/3 of total water volume in tank. **1.** Add pesticide(s) if desired and agitate until thoroughly mixed. **2.** Add Manganese5% EDTA and agitate until thoroughly mixed. **3.** Add adjuvant(s) if desired and agitate until thoroughly mixed. Fill tank with remainder of desired water. A jar test is recommended for evaluating compatibility of Manganese5% EDTA with multiple product mixtures.

USE RATES: **Broadcast:** 2–4 qt/acre. **2x2 or Band:** 1 qt/acre. **In-furrow:** 1–2 pt/acre. **Foliar:** 1 qt/acre.

KEEP OUT OF THE REACH OF CHILDREN: Avoid contact with skin, eyes, and clothing. Avoid breathing spray mist. Wash hands thoroughly after use. **Personal Protective Equipment:** Wear long-sleeved shirt and long pants, socks, shoes, and gloves.
