GENERAL INFORMATION: MaxxPower MP can be used with a starter fertilizer, in-furrow, in transplant water, or as a foliar treatment for any crop. Zinc and other micronutrients are often tied up by Phosphorus and compacted soils. Corn is the most sensitive crop to low Zinc levels in the soil. MaxxPower MP is fortified with Zinc EDTA and other vital micronutrients, organic acids, and vegetal protein hydrolysates. MaxxPower MP also consists of a dormant spore-based liquid that provides beneficial secretions to soil bacteria.

MIXING INSTRUCTIONS: Put 1/3 to 2/3 of total desired water volume in tank. **1.** Add pesticide(s) if desired and agitate until thoroughly mixed. **2.** Add desired amount of MaxxPower MP and agitate until thoroughly mixed. **3.** Add adjuvant(s) if desired and agitate until thoroughly mixed. Fill tank with remainder of desired water. A jar test is recommended for evaluating compatibility of MaxxPower MP with multiple product mixtures.

USE RATES: CORN: In-furrow: 1.5 qt/acre. **2x2:** Knife in at 1.5–2 qt/acre. Do not use less than a minimum of 2 gallons of carrier per acre. **Foliar:** 1.5 qt/acre at V4 to VT. **SOYBEANS: In-furrow:** 1.5 qt/acre. **2x2:** Knife in at 1.5–2 qt/acre. Do not use less than a minimum of 2 gallons of carrier per acre. **Foliar:** 1.5 qt/acre at V3 to R3. **GRAPES:** 1.5 qt/acre (at pre-bloom, at 60% bloom). **AERIAL:** 1.5 qt/acre with a minimum of 2 gallons of carrier per acre.
