Shake Well Before Using

GENERAL INFORMATION: MegaPower MP can be used with a starter fertilizer, in-furrow, in transplant water, or as a foliar treatment for any crop requiring Sulfur and Zinc. Corn is the most sensitive crop to low Zinc levels in the soil. MegaPower MP is fortified with Molybdenum, Sulfur, Zinc EDTA, organic acids, vegetal protein hydrolysates, and Phosphorus-liberating microbes. MegaPower MP also consists of a dormant spore-based liquid that provides beneficial secretions to soil bacteria.

MIXING INSTRUCTIONS: Put 1/3 to 2/3 of total desired water volume in tank. **1.** Add pesticide(s) if desired and agitate until thoroughly mixed. **2.** Add desired amount of MegaPower MP and agitate until thoroughly mixed. **3.** Add adjuvant(s) if desired and agitate until thoroughly mixed. Fill tank with remainder of desired water. A jar test is recommended for evaluating compatibility of MegaPower MP with multiple product mixtures.

USE RATES: CORN: In-furrow or 2x2: 2 qt/acre. Do not use less than a minimum of 2 gallons of carrier per acre. **Foliar:** 2 qt/acre at V4 to VT. **SOYBEANS: In-furrow or 2x2:** 2 qt/acre. Do not use less than a minimum of 2 gallons of carrier per acre. **Foliar:** 2 qt/acre at V3 to R3. **CEREAL GRAINS: In-furrow:** 2 qt/acre. Do not use less than a minimum of 2 gallons of carrier per acre. **AERIAL:** 2 qt/acre with a minimum of 2 gallons of carrier per acre.

NOTICE: Application of fertilizers containing Molybdenum may result in forage crops that contain levels of Molybdenum that are toxic to ruminant animals.
