**GENERAL INFORMATION:** Spreader820 is a nonionic surfactant adjuvant. It is designed to use with pesticides that require a nonionic surfactant. It may also be used with most insecticides, herbicides, fungicides, desiccants, and defoliants. Spreader820 increases contact activity through faster wetting, aids in penetration, and provides uniform coverage of sprays.

**MIXING INSTRUCTIONS:** Follow herbicide/pesticide manufacturer's labeled recommendations. Otherwise, Spreader820 may be used as shown on a per-100-gallon basis of final spray mix. Spreader820 nonionic surfactant should be the last ingredient added to the spray mixture. Agitate to ensure thorough mixing. Always refer to the pesticide and additive label(s) for additional directions or precautions. Follow the most restrictive label.

**USE RATES:** **Defoliants:** 1 qt/100 gallons of water. **Desiccants:** 1 qt/100 gallons of water. **Fungicides:** 1 pt/100 gallons of water. **Herbicides:** 1 qt/100 gallons of water. **Insecticides:** 1 pt/100 gallons of water.
