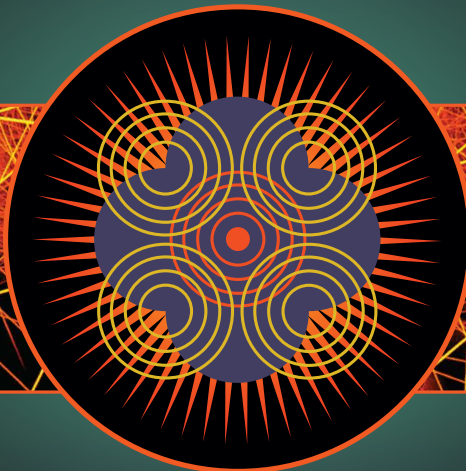

GENERAL INFORMATION: Vaporize is a specialized water-conditioning agent designed to enhance the performance of glyphosate and other weak acid herbicides. The proven ability of Vaporize to adjust pH creates a more acidic spray solution that protects the herbicides in the spray solution from antagonizing hard water ions like Calcium, Iron, Magnesium, and Manganese. This will allow glyphosate and other weak acid herbicides to stay in their most effective form. The addition of a low foaming surfactant in Vaporize reduces surface tension and enhances coverage on the leaf surface. This specially designed water-conditioning agent, pH adjuster, and surfactant system allows Vaporize to optimize glyphosate and other weak acid herbicides in some of the most challenging application conditions.

MIXING INSTRUCTIONS: Always mix Vaporize in accordance with the instructions concerning adjuvants found on pesticide labeling. In the absence of specific mixing instructions, fill the spray tank from 1/3 to 2/3 full with clean water. While the water is agitating add tank-mix ingredients in the following order: **1.** Water-soluble packets. **2.** Dry flowables and dispersible granules. **3.** Flowables. **4.** Water-soluble pesticides. **5.** Emulsifiable concentrates (continue agitation and finish filling the spray tank with water). **6.** Vaporize. **7.** Add additional adjuvants (maintain agitation while spraying to ensure a uniform spray mixture). **NOTICE:** Do not use Vaporize with any products containing Kixor® herbicide. (Kixor® is a registered trademark of BASF.)

USE RATES: 1–2 qt/100 gallons of water.
