**GENERAL INFORMATION:** popUPpower MP can be used with a starter fertilizer, in-furrow, in transplant water, or as a foliar treatment for any crop. Zinc and other micronutrients are often tied up by Phosphorus and compacted soils. Corn is the most sensitive crop to low Zinc levels in the soil. popUPpower MP is fortified with Zinc EDTA and vital micronutrients. popUPpower MP also consists of a dormant spore-based liquid that provides beneficial secretions to soil bacteria. popUPpower MP is intended as a supplement to a regular fertilizer program and will not, by itself, provide all the normal nutrients required by agricultural crops.

**MIXING INSTRUCTIONS:** Put 1/3 to 2/3 of total desired water volume in tank. **1.** Add pesticide(s) if desired and agitate until thoroughly mixed. **2.** Add desired amount of popUPpower MP and agitate until thoroughly mixed. **3.** Add adjuvant(s) if desired and agitate until thoroughly mixed. Fill tank with remainder of desired water. A jar test is recommended for evaluating compatibility of popUPpower MP with multiple product mixtures.

**USE RATES (IN-FURROW/2x2/FOLIAR/AERIAL): CORN: In-furrow:** 1 qt/acre. **2x2:** Knife in at 1–2 qt/acre. Do not use less than a minimum of 2 gallons of carrier per acre. **Foliar:** 1 qt/acre at V3 to VT. **SOYBEANS: In-furrow:** 1 qt/acre. **2x2:** Knife in at 1–2 qt/acre. Do not use less than a minimum of 2 gallons of carrier per acre. **Foliar:** 1 qt/acre at V3 to R3. **GRAPES:** 1 qt/acre (at pre-bloom, at 60% bloom). **AERIAL:** 1 qt/acre with a minimum of 2 gallons of carrier per acre.

**KEEP OUT OF THE REACH OF CHILDREN:** Avoid contact with skin, eyes, and clothing. Avoid breathing spray mist. Wash hands thoroughly after use. **Personal Protective Equipment:** Wear long-sleeved shirt and long pants, socks, shoes, and gloves.
