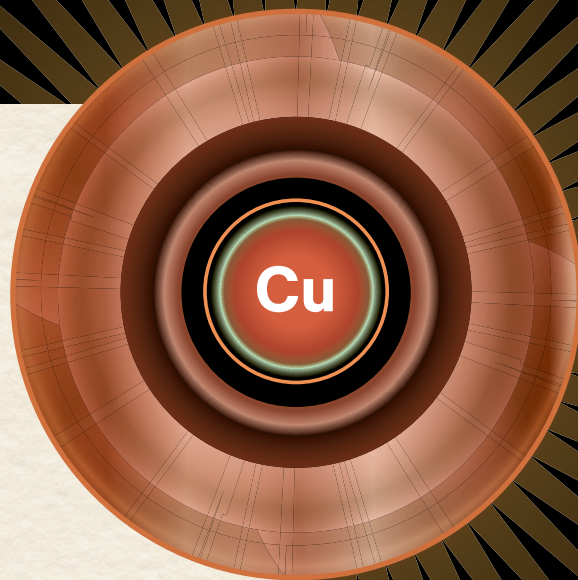

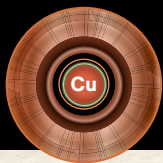

GENERAL INFORMATION: Copper5.4% is formulated to provide crops with an easily absorbed source of Copper, an essential micronutrient that supports plant growth and overall plant health. For maximum effectiveness, it should be applied under conditions of moderate temperatures, adequate soil moisture, and humidity. Foliar applications are most effective when plants absorb nutrients in the early morning or late evening.

MIXING INSTRUCTIONS: Put 1/3 to 2/3 of total water volume in tank. **1.** Add pesticide(s) if desired and agitate until thoroughly mixed. **2.** Add Copper5.4% and agitate until thoroughly mixed. **3.** Add adjuvant(s) if desired and agitate until thoroughly mixed. Fill tank with remainder of desired water. A jar test is recommended for evaluating compatibility of Copper5.4% with multiple product mixtures.

USE RATE: **Corn:** 8 oz/acre at V4–V8. **Soybeans:** 1 qt/acre at V3–R1. **Cereal Grains:** 1 pt/acre at stage 2 to stage 4. **Forage Crops and Pastures:** 1 pt/acre. **Fruiting and Leafy Vegetables:** 1 qt/acre. **Tree Fruit:** 1–2 qt/acre.
