GENERAL INFORMATION: Iron5% is a product designed to prevent and correct Iron deficiencies in crops. It can be applied to the soil or as a foliar spray. Application rates should be based on the specific deficiency, and for optimal results, follow sound agronomic practices, including soil testing and tissue analysis.

MIXING INSTRUCTIONS: Put 1/3 to 2/3 of total water volume in tank. **1.** Add pesticide(s) if desired and agitate until thoroughly mixed. **2.** Add Iron5% and agitate until thoroughly mixed. **3.** Add adjuvant(s) if desired and agitate until thoroughly mixed. Fill tank with remainder of desired water. A jar test is recommended for evaluating compatibility of Iron5% with multiple product mixtures. Optimum results with this product is obtained if the pH of the tank mix is between 5 and 6.

USE RATES: **Broadcast:** 2–8 qt/acre. **Foliar:** 1–4 qt/acre.

USE PRECAUTIONS: DO NOT spray Iron5% within 30 days after application of any Copper-containing products. DO NOT store mixed product for more than 8 hours. DO NOT mix or apply in combination with Calcium-containing products, amine herbicides, Copper-containing fungicides, sulfates, phosphates, phosphonates, and highly alkaline materials, such as Lime Sulphur, MCPA, or highly alkaline Boron products. DO NOT exceed the appropriate application rates.
