GENERAL INFORMATION: M-Power is a dormant spore-based liquid that provides beneficial secretions to soil bacteria. These spores are extracted from useful, naturally occurring microbes. M-Power is complimentary and compatible with herbicides, insecticides, fungicides, and liquid or dry fertilizer. M-Power can be used on any crop and on irrigated or dry land. For best results apply M-Power at pre-planting or planting followed by a foliar application.

MIXING INSTRUCTIONS: Put 1/3 to 2/3 of total water volume in tank. **1.** Add pesticide(s) if desired and agitate until thoroughly mixed. **2.** Add M-Power and agitate until thoroughly mixed. **3.** Add adjuvant(s) if desired and agitate until thoroughly mixed. Fill tank with remainder of desired water.

USE RATES: ALL CROPS: Broadcast: 1 pt/acre. **In-furrow:** 1 pt/acre. **Foliar:** 1 pt/acre. **TURF GRASS:** 1 qt/acre or 1 oz/1000 square feet.
