GENERAL INFORMATION: N-Ergize HL can be counted on to manage Nitrogen availability when your plants need it the most. N-Ergize HL helps to reduce leaching and denitrification in the soil. N-Ergize HL can be blended with urea and urea ammonium nitrate (UAN) fertilizers. *Patented formulations covered by: U.S. patent numbers 9,637,420 and 9,650,306.*

MIXING INSTRUCTIONS: Liquid Nitrogen (UAN): Fill the blend unit half full of UAN and add N-Ergize HL at the appropriate rate for the entire load and mix together. Add the remaining UAN solution and mix thoroughly prior to the addition of any other materials. A jar test is recommended for evaluating the compatibility of N-Ergize HL with multiple product mixtures. **Dry Urea:** Accurately weigh all materials in the blend formula. Add urea in the blender. N-Ergize HL should be blended with urea before introducing any other fertilizer components. Allow enough mixing time so that it produces a uniformly blended product.

USE RATES: Liquid Nitrogen (UAN): 1 qt/ton. **Dry Urea:** 2 qt/ton. **Liquid Manure:** 3 oz/acre. General rate recommendations are based on average conditions. Rates may be adjusted higher as needed based on field and weather conditions.
