GENERAL INFORMATION: PK Power is a highly concentrated potash solution that plants rapidly absorb through leaves and roots. It provides a readily available source of Potassium. PK Power can be used on a wide variety of crops.

MIXING INSTRUCTIONS: Put 1/3 to 2/3 of total water volume in tank. **1.** Add pesticide(s) if desired and agitate until thoroughly mixed. **2.** Add PK Power and agitate until thoroughly mixed. **3.** Add adjuvant(s) if desired and agitate until thoroughly mixed. Fill tank with remainder of desired water. A jar test is recommended for evaluating compatibility of PK Power with multiple product mixtures.

USE RATES: **Corn:** 1–2 qt/acre at V4 to VT; 1–2 pt/acre in-furrow. **Soybeans:** 1–2 qt/acre at V3 to R3. **Cereal Grains:** 1–2 qt/acre at stage 2 to stage 8 or at stage 10.1 to stage 10.5. **Fruiting and Leafy Vegetables:** 1–2 qt/acre per application as part of a regular spray program. **Ornamentals:** 1–2 qt/100 gallons of water. Apply until the crop has a sufficient level of Potassium. Cover foliage thoroughly to the point of runoff.
