GENERAL INFORMATION: Shred-It is a soil health and mineralization solution that integrates a custom blend of selected bacteria. These bacteria work together synergistically to break down crop residue and effectively promote nutrient recycling.

DIRECTIONS FOR USE: Shred-It can be used on all soil types and crop residues—apply post-harvest or post-cover crop. It can be applied on impregnated dry fertilizer, broadcast liquid applications, with boom sprayer and pivot irrigation. Shred-It is tank mix compatible with most fertilizers, surfactants, herbicides, insecticides, fungicides, and soil amendments. Once the product tank mix has been made, spray within three days. Agitate well for 3 to 5 minutes before use.

USE RATES: **Broadcast:** 12.8 oz/acre.
