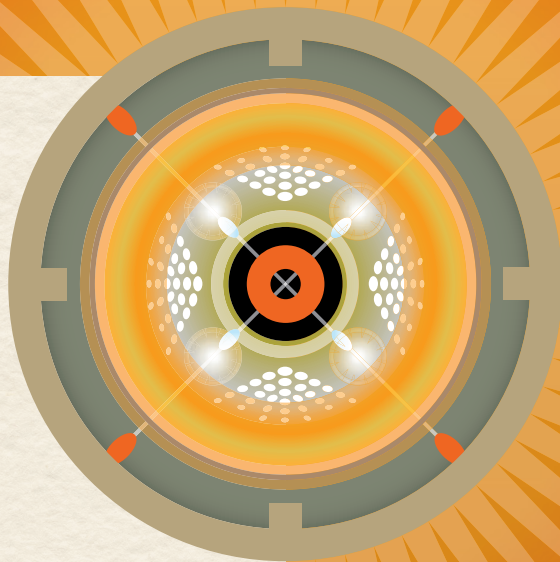

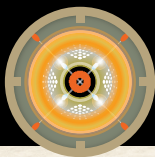

GENERAL INFORMATION: TotalPro is an advanced, all-in-one adjuvant. It conditions the water by binding and neutralizing hard water minerals, and with the added power of AMS, TotalPro enhances water quality for maximum pesticide performance. The nonionic surfactant in TotalPro improves the distribution of pesticides, allowing them to spread evenly across plant surfaces and penetrate deeper into the canopy for enhanced coverage. By reducing the formation of fine spray droplets, TotalPro acts as a drift control agent, reducing off-target movement and keeping your applications precise and efficient. TotalPro also includes an antifoaming component to make tank mixing faster and easier, ensuring smooth operations without delays.

MIXING INSTRUCTIONS: Always mix TotalPro in accordance with the instructions found on the pesticide label. In the absence of specific mixing instructions, fill the spray tank from 1/3 to 2/3 full with clean water. While the water is agitating, add tank-mix ingredients in the following order: **1.** Water-soluble packets. **2.** Dry flowables and dispersible granules. **3.** TotalPro **4.** Flowables. **5.** Water-soluble pesticides. **6.** Emulsifiable concentrate—continue agitation and finish filling the spray tank with water.

USE RATES: 2–4 qt/100 gallons of water.

USE PRECAUTIONS: Not for aquatic use. Follow the recommendations of the most restrictive active ingredient label. Tank mixtures should only be applied within the label recommendations of every product in the tank mixture.

Do not contaminate water supplies. **STORE BETWEEN 40° AND 90 °F.** **Disposal:** Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all federal, state and local regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
