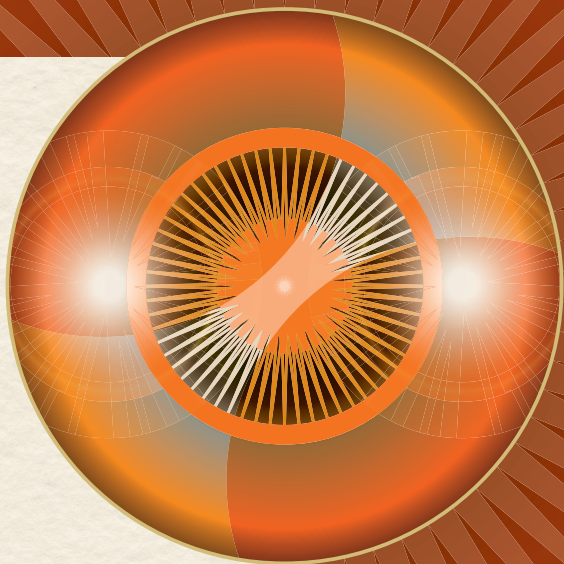

GENERAL INFORMATION: CitraCore is a powerful surfactant designed for use with insecticides, miticides, fungicides, herbicides, plant growth regulators, defoliants, and nutrients. It provides superior spreading, penetration, and uniform distribution, enhancing both the physical and chemical properties of the spray solution. CitraCore also helps overcome water repellency on leaf surfaces, ensuring better absorption and effectiveness.

MIXING INSTRUCTIONS: Fill the tank halfway with water and begin agitation. Add the required amount of other tank mix products while maintaining agitation. Once mixed, add the remaining water. Add the recommended amount of CitraCore last, continuing agitation until spraying is complete. For best results, use within 24 hours of mixing. If needed, antifoam and buffering agents may be used.

USE RATE: Herbicides, Insecticides, Fungicides, Miticides, and Foliar Nutrients: 1–4 pt/100 gallons of water. Use higher rates on weeds with waxy or hairy leaf surfaces that are hard to penetrate. **Defoliants/Desiccants:** 1–2 qt/100 gallons of water. **Aerial:** 1 oz/gallon of water.

USE PRECAUTIONS: Not for aquatic use. Do not apply to the fruiting stages of pome fruit, cherries, table grapes, or other sensitive or stressed crops without first consulting your PowerAG representative. When tank mixing with EC products, Copper, and/or Chlorpyrifos on sensitive crops, conduct a compatibility test before application. **Note:** CitraCore can reduce dew formation for up to seven days, which may increase the risk of frost damage in frost-prone areas.
